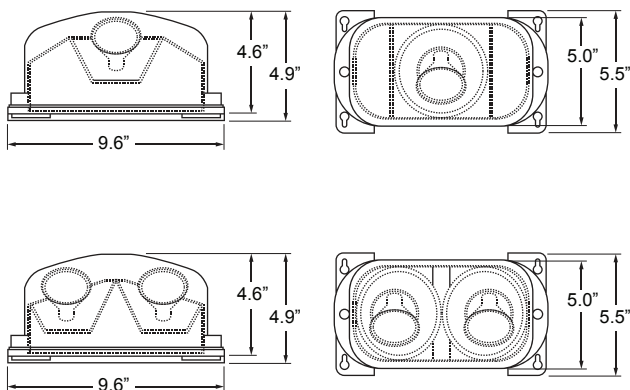

The IND family offers protection against humidity, dust, and water infiltration and is comprised of the INDWLEZU (Exit Sign), INDCWLEZU (Exit Combo), INDEMR16 (Emergency Lighting Unit), and INDRHLED16 (Remote Head). The reinforced polycarbonate enclosure with impact-resistant, UV-stable polycarbonate lens is suitable for vandal-prone areas and Wet Locations.

CONSTRUCTION

The INDRHLED16 Series enclosure is made of UV-stable, reinforced polycarbonate coupled with a polycarbonate lens, corrosion-resistant hardware, and a molded gasket to provide protection for the equipment inside against ingress of solid foreign objects (dust) and water.

ILLUMINATION

One (1) or two (2) fully adjustable, attractive lamp heads allow for maximum light to be delivered to the path of egress. Emergency lights feature (3) LEDs x 1.1W per LED for 3.3W per lamp head that delivers 219 lumens in each MR16 style lamp head to provide optimal center-to-center spacing.

INSTALLATION

Universal knockout pattern on back provided with gasket for water-tight seal for back mount.

CONFORMANCE TO CODES & STANDARDS

The INDRHLED16 Series is UL Listed for Wet Locations and meets or exceeds the following: NEC requirements and NFPA 101.

OPTIONS

Tamper-Proof Hardware (Option: TP)

Tamper-proof hardware adds an additional layer of protection to the unit, preventing unwanted access to the interior of the unit or removal of the lens.

NEMA 4X Rated (Standard)

NEMA 4X rated fixtures are designed for outdoor applications. NEMA 4X rating ensures that the fixtures will withstand contact with falling dirt, moderate or jet-driven water, ice and corrosion. NEMA 4X fixtures are designed to perform in Hose-Down applications.

IP66 Rated (Standard)

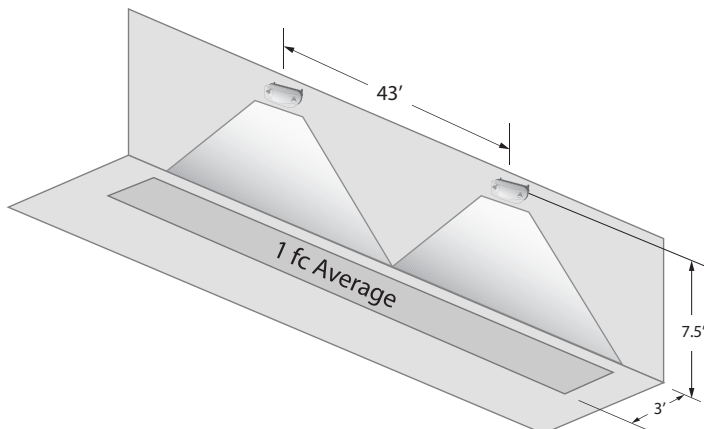
IP66 rating ensures that the product can be installed in outdoor applications where significant water or dust may come in contact with the fixture. IP66 rated fixtures are fixtures designed to perform in Hose-Down applications.

NSF Certified (Standard)

NSF certification ensures that the equipment has been evaluated, tested, and certified by NSF International as meeting international commercial food equipment standards and that the product can be installed in food processing applications.

SAMPLE PHOTOMETRICS - 3' PATH OF EGRESS

Using multiple NXFR double head units mounted at a typical 9' height delivers 43' on-center spacing with a 3' wide path of egress using 80/50/20 reflectances.



SAMPLE PHOTOMETRICS - 6' PATH OF EGRESS

Using multiple NXFR double head units mounted at a typical 9' height delivers 40.5' on-center spacing with a 6' wide path of egress using 80/50/20 reflectances.
